## RECOMMENDATIONS RELATED TO THE STANDARDS

Although all standards are determined to have been met, the following recommendations are submitted for your consideration:

- Standard 9.e. Consider more gathering space for students
- **Standard 10.b.** Make it easier for students to identify a person to evaluate transcripts
- **Standard 12.c.d.e.f.** Strengthen this standard by including more info about organizational structure of communities; capacities, limitations, and resiliency of human systems; documentation of annual activity plans as to how diversity is incorporated into the curriculum
- **Standard 13.b.** Consider emphasizing the range of populations served and the needs addressed by human services. **d.** What could be done to move from medium to heavy emphasis of economic and social class systems?
- **Standard 16.** Consider more emphasis on case management.
- HDAL 3510 and HDAL 3610 carry most of the curriculum related to CSHSE Standards. Consider showing more evidence that the Standards are pronounced in other courses.
- HDAL 4950 relates to research in learning and development. Consider showing more evidence of this being incorporated into other courses.

### RECOMMENDATIONS NOT RELATED TO THE STANDARDS

We would encourage the infusion of Cultural Competence into the curriculum. CSHSE will have a new standard in the near future that addresses this issue. Look for guidance on our website, to include articles in the *Bulletin* about best practices.

Your next reaccreditation will be February, 2021. No site visit will be necessary at that time. Please include this letter in your self-study. Also – it will be important to consult the CSHSE website for any changes in Standards or format.

You will receive a formal letter and Certificate of Accreditation from Elaine Green, President of CSHSE.
